#### Oral amendments to L. 60

Global efforts for the total elimination of racism, racial discrimination, xenophobia and related intolerance and the comprehensive implementation of and follow-up to the Durban Declaration and Programme of Action

#### Preambular Section

**PP1**, In the  $6^{th}$  line, replace "World Conference" with "Durban Declaration and Programme of Action". In the  $7^{th}$  line, replace "their" with "its".

Replace **PP3**, **PP4** and **PP5** with the following paragraph – "Recalling its resolution 64/148 of 26 March 2010 which, amongst others, called for the 10<sup>th</sup> Year Commemoration of the Durban Declaration and Programme of Action of the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance (WCAR), which represents an important opportunity for the international community to reaffirm its commitment to the eradication of racism, racial discrimination, xenophobia and related intolerance, including by mobilizing political will at the national, regional and international level aimed at generating concrete results."

#### Delete PP6.

In **PP7**, in the fourth line, delete "and deeply regretting the slow progress made in discharging its mandate" and replace it with "and encourages the Committee to continue making progress in the discharge of its mandate".

### Delete PP12 and PP13

In **PP17**, in the fourth line, after "recognizing" insert "the continuing" so that it reads as follows "and recognizing the continuing need for the High Commissioner to make this a cross-cutting issue in the activities and programmes.." and replace "her Office" with "the Office" on the last line.

**PP18,** in the first line, delete "also, the conclusions and recommendations" and add on the last line after "the Durban Declaration and Programme of Action", the following "and looks forward to the Human Rights Council's consideration of those conclusions and recommendations"

**PP15bis.** Insert the following paragraph as new PP15bis. "Acknowledges the centrality of resource mobilization, effective global partnership and international cooperation in the context of paragraphs 157 and 158 of the Durban Programme of Action for the successful realization of commitments undertaken at the World Conference,"

PP20. Insert on the first line the word "recent" before "hosting" to read "Welcoming the recent hosting of the 2010", delete "and 2014". On the second line, after "South Africa and" insert the following formulation "looking forward to the forthcoming 2014 International Federation of Association Football World Cup" in Brazil, then delete the word "respectively" in the second line.

**OP3**. On the last line after "...the Durban Declaration and Programme of Action", insert, " and the Outcome Document of the Durban Review Conference"

**OP4.** Add at the end of the paragraph on the fourth line after victins, add the following "recognizing that combating racism, racial discrimination, xenophobia and related intolerance is a primary responsibility of states"

**OP5.** On the third line, include after "related intolerance which", the following wording - include inter alia, xenophobia, racial profiling, incitement to racial, ethnic or religious hatred", and continue the rest of the paragraph, to read as as follows: '...related intolerance, which include inter alia, xenophobia, racial profiling, incitement to racial, ethnic or religious hatred, propagating racist and xenophobia acts ..."

**OP8.** On the fourth line, delete "other related" and insert after "grounds", the following phrase "specified in the Durban Declaration and Programme of Action". This will now read as follows "discrimination based on grounds specified in the DDPA, such as sex...." At the end of the paragraph, delete "or other status".

**OP13.** Insert at the end of the paragraph "and the outcome document of the Durban Review Conference"

**OP 23.** On the first line, after "Member States to", insert "do their utmost to" so that it reads, "Calls upon Member States to do their utmost to...". In the second line, replace the word "should" with "do".

# Special Rapporteur on contemporary forms of racism, racial discrimination, xenophobia and related intolerance, and follow-up to his visits

**OP25.** In the first line, insert after the word "Special Rapporteur" the phrase "on contemporary forms of racism, racial discrimination, xenophobia and related intolerance", to read Special Rapporteur "on contemporary forms of racism, racial discrimination, xenophobia and related intolerance" and welcomes Human Rights Council resolution 7/34 of 28 March 2008,

OP29. In the first line, replace "closer" with "the close".

**OP30.** In the first line, replace "urges" with "request", and insert "continue to" between the words "to" and "provide". The paragraph will read as "Request" the High Commissioner to continue to provide States..."

**OP31.** Insert in the first line "continue to" before "provide" to read "Requests the Secretary-General to continue to provide the Special Rapporteur..."

**OP32.** Insert ", within his mandate" after Special Rapporteur, to read "Requests the Special Rapporteur, within his mandate, to continue giving particular attention ..." End the paragraph after "social rights" and delete rest of paragraph.

**OP34.** Insert on the third line after "education" the words "including human rights education and learning", to read "...emphasizes the crucial role of education, including human rights education and learning, and a variety of awareness-raising measures which contribute to creating tolerant ...

**OP35.** In the first line, delete "closely". In the second line after "societies", replace "so that this concept will not be" with the following, "with a view to preventing it from being". The paragraph will read "...Recommends that all States give due attention to and monitor the way in which the concept of national identity is debated within their societies, with a view to preventing it from being used as a tool to create artificial differences among some groups of the population."

**OP36.** In the last line, replace "this regard" with "combating racism, racial discrimination, xenophobia and related intolerance".

**OP37.** In the first line, after "human rights training", insert the following "including on challenges of racism, racial discrimination, xenophobia and related intolerance faced by migrants, refugees and asylum-seekers". The paragraph reads "Recommends that Sates conduct human rights training including on challenges of racism, racial discrimination, xenophobia and related intolerance faced by migrants, refugees and asylum-seekers, to law enforcement officials,..."

**OP38.** In the fourth line, replace the phrase "consent of the concerned", with "the consent of those concerned".

**OP45.** At the end of the paragraph, add "and the outcome document of the Durban Review Conference"

Delete **OP49** and **OP50** and replace this with the following new paragraph. "Decides to hold a one-day High-Level meeting of the General Assembly to commemorate the Tenth Anniversary of the Adoption of the Durban Declaration and Programme of Action, at the level of Heads of States and Governments, on the second day of the General Debate of the 66<sup>th</sup> Session of the General Assembly, under the theme "Victims of racism, racial discrimination, xenophobia and related intolerances: Recognition, Justice and Development", consisting of an opening plenary, consecutive round tables/ thematic panels and a closing plenary meeting; and calls on the President of the General Assembly to appoint co-facilitators to conduct consultations on the scope, modalities, format and organization of the High Level meeting.

OP51. In the first line, before the word "Declaration", add the word "political". In the second line, after "political will", add "at the national, regional and international levels". In the last line, replace "the outcome of the 2009 Durban Review Conference" with the words "its follow-up processes." OP56. In the third line, after "Programme of Action", insert "and the Outcome Document of the Durban Review Conference"

Delete OP61.

**OP62.** Replace OP62 with the following paragraph -"Calls upon the Human Rights Council to ensure that upon the consideration and adoption of the conclusions and recommendations of the Intergovernmental Working Group for the effective implementation of the Durban Declaration and Programme of Action, the recommendations are brought to the attention of the relevant agencies for adoption and implementation within their respective mandates"

**OP63.** Replace OP63 with the following paragraph "Encourages the High Commission for Human Rights to continue mainstreaming the implementation of the DDPA in the whole UN system, and in accordance with paragraphs 136 and 137 of the outcome document, which calls for the establishment of the inter-agency task, to update the Human Rights Council in this regard;

OP65. In the first line, before the word "provide", insert the words "continue to"

**OP66.** Replace current OP66 with this new paragraph "Recalls the request to the Human Rights Council to consider necessary measures to enhance the effectiveness of the follow up mechanisms to the DDPA and to ensure better synergy and complementarities in the work of these mechanisms and looks forward to the discussions with a view to enhance the interface among and focus of follow up mechanisms with a view to achieve greater synchronization and coordination at all levels, within their respective mandates, including through restructuring and reorganization of their work if deemed appropriate by the Human Rights Council, and to allow joint discussions and meetings"

OP69. In the third line, replace the word "reverse" with the word "end"
